## Minutes:

 Approval of the Draft Community Preservation Committee Regular Meeting Minutes from February 11, 2021.

Letters of Intent: None received. Applications:

- An Application was received from the Cape Cod Center for the Arts, Inc.-DBA The Cape Playhouse, Dennis MA requesting \$100,000 in Barnstable CP Historic Preservation funds for the restoration of the eastern side of the Playhouse. Project includes re-shingling, trim replacement, installation of new gutters, downspouts and dry wells, new doors and sills, new staircases to the balcony, and window replacement or restoration. Total project cost is \$650,000 with secured funding in the amount of \$550,000.
- An Application has been received from the Town Manager and Department of Public Works requesting funds for improvements to the small playground located at the Barnstable Hollow field. Two alternatives are proposed for consideration, including reuse of the existing playground equipment or replacement of the existing equipment. Both alternatives will include the provision of handicapped access, new play area surfaces and safer transition between the playground and the field; signage, seating with shade, seasonal water, and trash bins. This Community Preservation Recreation/Open Space funding request for the alternative to reuse existing playground equipment is \$80,000. The funding request for the alternative for new playground equipment is \$125,000. Completion of the project is estimated for spring of 2021.
- An Application has been received from the Town Manager and the Department of Public Works seeking Community Preservation Open Space/Recreation Funds in the amount of \$816,793 for a new playground at the Centerville Recreation Building. This new playground will replace the existing aging outdated equipment and include the creation of an accessible pathway from the parking area. Work will also include the installation of the new playground as coordinated with the community and new assessable surfacing, landscaping and new accessible path. Completion of the project is estimated for summer of 2021.

In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located.
