Representative, Robert Smith in attendance. He explains that there is movement in the deck. The flooring is peeling and nails coming through. Corroded joyce hangers. Need to replace. Railings have a lot of decay as well, posts also. See Exhibit A, proposing to use PVC. Ramp is not compliant and cracked. New ramp proposing to move out from the building, create a garden area here, this would make compliant with access board. Metal railings for the ramp, still use white color. Proposing grey Azek to replace decking.

Chair Cheryl Powell clarifies that just the ramp is metal railings. Robert Smith replies, yes.
