Chair Cheryl Powell reads into record the HHDC's FY202 Annual Report; Hyannis Main Street Waterfront Historic District Commission (HHDC)ANNUAL REPORT FY 2020

Now in its twenty-fifth year, the Hyannis Main Street Waterfront Historic District Commission (HHDC) was created under MGL Chapter 40C and charged with implementing Chapter 112, Article III of the Code of the Town of Barnstable. The District Commission is committed to the revitalization of downtown Hyannis, the preservation of historic structures, and the enhancement of the unique character of downtown Hyannis and the Hyannis Inner Harbor. The Commission works to maintain the scale, character and style of the area through the preservation and promotion of historic characteristics of buildings and places under the guidance of the Secretary of the Interior's 'Standards for the Treatment of Historic Properties.'

HHDC is proud to continue participating in many positive changes in the District, including new construction, business expansion, building improvements through restorations and upgrades, public art installation, landscape improvements, energy efficient solar panel installation and signage. The Commission continues working creatively with businesses in promoting the use of historic signage and symbols to create a welcoming experience for residents and visitors. Respect and appreciation of our historic architecture has given new direction to the adaptive reuse structures that enhance the presence of a diverse array of businesses, especially at the waterfront.

During Fiscal Year 2020 the Commission met 22 times and reviewed 37 applications. The following is a summary of the applications reviewed by the Commission from July 1, 2019 to June 30, 2020:

Minor Modification to Approved COA

David Colombo recuses himself.

Elizabeth Wurfbain in attendance, President of the Business Improvement District (BID), in representation for David Colombo. She explains three parts, the artwork, and side curtains on the awning, and clarification of something at previous meeting.

<u>First</u>: To install artwork, Exhibit A, picture of artwork/signage. Proposing to make a replica of this and have at corner of garden at Colombo's. Made by student artist from Cape Cod Tech. Arrows pointing in two different directions. Has colonial cap, made of wood, 6ft. tall. To be placed near lit tree on private property. Site plan, Exhibit B, shown where this would be placed.

Chair Cheryl Powell confirms private and not public property to be placed on.

<u>Second</u>: Elizabeth Wurfbain, side curtains for awning system, like used at Black Cat. Half clear and same tan color in the awning system now being used.

<u>Third</u>: Elizabeth Wurfbain asks for clarification that the replaced awning will be all one system, same new one as proposed to be used. Applicant will be changing existing to match new one that was approved.

Chair Cheryl Powell clarifies that this minor modification (clarification of awning to be used and curtain) is not on the application, but need to add this third part when approving.

Chair Cheryl Powell asks for any public comment. None. Chair closes public comment.

Chair Cheryl Powell clarifies awning, existing one is different from the one approved.

Betsy Young comments that she has seen this type of signage around and tourists like them. They add to the flavor of Main St. The awning curtains are good to have because of weather.

Chair Cheryl Powell states that this seems to be more like artwork and not signage.

Chair Cheryl Powell entertains a motion for the Findings, moved by Betsy Young to find this application to be compatible with the preservation and protection of the district with clarification that the existing awning (black and tan stripes) will be replaced to match the new awning as described in previous meeting, seconded by Jack Kay, Roll Call Vote:
