Eric Johnson, Area Manager for Papa Gino's, appeared on behalf of the applicant. Mr. Johnson noted that New England Authentic Eats LLC took ownership of Papa Gino's Inc. All operating procedures are to remain the same. Applicant is seeking approval for a total of 80 indoor seats as approved by Building Commissioner, Brian Florence on 11/06/2019.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to amend the Annual Common Victualler License to reflect the current owner, New England Authentic Eats LLC and to correct the seating capacity allowing for 80 total seats as approved by Building Commissioner, Brian Florence 11/06/2019.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to approve the application of 3660 Main Inc. d/b/a Ashley Manor, 3660 Main Street, Barnstable, Allison S. Mackie, Manager for a New Lodging House License for 6 rooms/12 lodgers.

Richard Scali noted that a special permit and variance was approved at the December 11, 2019 Zoning Board of Appeals Hearing. It was formally filed on December 20, 2019. The Lodging House License will be issued after the 21 day appeal period has expired.

3. <u>Discussion of alternative penalties for underage compliance check violations; Officer Therese Gallant</u>

Officer Gallant explained that after speaking with Lt. Murphy, Mr. Scali and the Licensing Authority, she compiled a list of alternative penalties to use as an option for first time violators. The hope is to keep the focus on education rather than imposing a standard monetary fine, where applicable. Officer Gallant favors using a Continued Without A Finding (CWAF) ruling, noting that in such instances there is an understanding of a guilty finding yet it does not go forward as a criminal charge. Officer Gallant explained that such penalties would be applicable to first time offenders as well as longstanding establishments with no prior violations on their record. Officer Gallant suggested allowing an establishment the option of making a monetary donation to a charity such as the Barnstable High School After Prom Celebration in lieu of the standard fine. Such

penalties would be fitting and in keeping with the ultimate goal of preventing underage drinking. Other alternative penalties might include hosting a TIPS training session or purchasing reference materials such as Identification Resource guides. These alternatives would be fitting penalties and in turn benefit the community. Officer Gallant intends that the charitable options align with our standard fee schedule.

Mr. Decker inquired about the current procedure when a minor is caught utilizing a fake ID.

Officer Gallant noted that in recent instances the offenders were forthcoming. The parents of the minors were contacted and the ID's seized. All incidents are documented in a Police database, which each department has access to. In the instance of a second offense, the details of a previous incident will be known. Legally, the minor may be charged with a felony. A required court appearance or a fine may also be imposed.

Ms. Karlson-Lidman asked if imposing a mandatory closure equates to a more severe monetary penalty for the business.

Officer Gallant explained that in some cases, yes. However, a closure penalizes not only the business, but each employee as well, including those who were not involved in the particular incident. Allowing for alternative penalties gives those who qualify an opportunity to turn a negative situation into a positive one through education.

Licensing Division Updates:

1. Licensing Department updates -

Director, Richard Scali reports that all Alcohol establishments have paid the required fees. Approximately six establishments are not renewing. Six Common Victuallers and (3) Class II Auto establishments are pending renewal. The ABCC report has been submitted.

Chairman, Martin Hoxie asked Mr. Scali if he had any inclination as to why the six alcohol establishments have chosen not to renew despite the positive economy. Mr. Scali explained that a few establishments are in the process of an ownership transfer and others could not sustain enough business to remain open.
