SUBJECT: Acceptance of a Fiscal Year 2021 Municipal American Disability Act Improvement

Grant in the amount of \$250,000 from the Massachusetts Office on Disability for completion of an American Disability Act Self-Evaluation and Transition Plan

BACKGROUND: The Town of Barnstable was awarded a \$250,000 planning grant from the Massachusetts Office on Disability on behalf of the Secretary of the Executive Office for Administration and Finance (EOAF). The Project scope includes completion of an Americans with Disabilities Act (ADA) Self-Evaluation and Transition Plan encompassing all of the Town's facilities, activities, programs and services. The process involves a comprehensive self-assessment of municipal assets, activities, and programs and the development of a transition plan to improve accessibility. The completion of an ADA Self-Evaluation and Transition plan is a prerequisite to a number of state grant programs. The project must be completed by June 30, 2021.

FISCAL IMPACT: No funding match is required by this grant program. The Town will support this grant through the dedication of staff time for project oversight and management. This is a reimbursable grant and the grant award will be disbursed upon documentation of incurred expenses and invoicing the Commonwealth for reimbursement.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager recommends acceptance of this grant.

SUBJECT: Acceptance of the grant of a water easement from OCW Retail-Hyannis, LLC for water

main extension

BACKGROUND: As part of the sidewalk extension project funded by a MassWorks grant, the Department of Public Works will be installing a water main extension which will connect an existing "dead-end" water main on Attucks Lane to the existing water main loop located on the property controlled by OCW Retail-Hyannis, LLC (currently the Home Depot). As the water main loop is located on private property, it will be necessary to obtain an easement to allow for the construction, maintenance, repair and use of the water main extension.

ANALYSIS: During the development of the sidewalk extension project funded by a MassWorks grant, DPW staff identified the opportunity for improvements to the Hyannis Water System by eliminating a "dead-end" located on Attucks Lane. This would be accomplished by the construction of a 680-foot water main extension, connecting the "dead-end" on Attucks Lane to the looped water main on the property controlled by OCW Retail-Hyannis, LLC (currently the Home Depot). Elimination of the "dead-end" will result in improved water pressure, fire flows and water quality within this portion of the Hyannis Water System. OCW Retail-Hyannis, LLC agreed to gift an easement to the Town in order to complete this work.

FINANCIAL IMPACT: This easement will be acquired at no cost to the Town. Construction of the water main extension will be funded by available funds in the Hyannis Water Fiscal Year 2020 Pipe Replacement Capital Appropriation. As this work is being conducted as part of a larger contract, the cost of the construction is significantly less than it otherwise would be. Should savings be realized elsewhere in the sidewalk project, there may be an opportunity to utilize MassWork grant funds to fund a portion of the water main extension work to realize additional savings for the Hyannis Water ratepayers.

BACKGROUND: In August 2020, the Town received a Notice of Intent to Sue letter from the Conservation Law Foundation ("CLF") alleging violation of the federal Clean Water Act for operating the Town's wastewater treatment facility without obtaining a National Pollutant Discharge Elimination System permit for the discharge from the facility. In September 2020, the Town received a second Notice of Intent to Sue letter from CLF alleging violation of the Massachusetts Title 5 septic regulations. CLF did not present specific demands, but the letters threatened pursuit of injunctive relief that could require the Town's expenditure of millions of dollars. In addition, with respect to CLF's Clean Water Act allegations, the letters threatened penalties of approximately \$50,000 per violation per day for the past five (5) years.

The law firm of Anderson & Kreiger has substantial experience, knowledge and expertise in this very complex area of the law and has handled similar matters on behalf of other clients.

FISCAL IMPACT: The relief and penalties that may be sought by CLF, if granted, would have a substantial financial impact on the Town, and it is therefore critically important that the Town have the benefit of representation by counsel with significant experience and expertise in these types of matters. Funding for this appropriation is being provided from the General Fund reserves which have been certified at \$18.5 million as of July 1, 2020.

\$39,999.80 from the Executive Office of Public Safety and Security

BACKGROUND: The Department applied for and was awarded this grant in the amount of \$39,999.80. This funding will enable the Traffic Division to participate in five traffic mobilizations designed to target specific areas of concern with motorists as follows:

- 1. Winter Impaired Driving Focus (December 16, 2020 January 23, 2021)
- 2. Distracted Driving (April 2 18, 2021)
- 3. Click It or Ticket (May 17 31, 2021)
- 4. Speed (June 11, 2021 and June 27, 2021)
- 5. Summer Impaired Driving Focus (August 20,2021 September 6, 2021)

This grant helps to raise awareness of both traffic safety challenges involving drinking and driving, distracted driving, and seatbelt usage. This grant also incorporates traffic enforcement equipment that is needed by the traffic division, as well as distracted driver and drunk driver education to junior high and high school student. This MRS grant replaces the Traffic Enforcement and Local Sustained Traffic Enforcement Program (STEP) Grant offered in the past years.

GRANT DETAIL: \$34,963.50 of this grant is allocated entirely to traffic enforcement, \$1,950.00 will be allocated to a Covert Speed Tracker, and \$3,086.30 will be allocated for Driver education for minors using a distracted driver Mat, Flyers, and a drinking and driving mat.

ANALYSIS: Acceptance of this grant will assist the Department in the continuance of these important traffic safety mobilizations.

FISCAL IMPACT: This grant funds the overtime costs of conducting the five mobilizations, equipment and educational materials. There is no required match and the overtime costs, equipment, and materials of the grant will be reimbursed following the completion of each mobilization and submission of payment for materials and equipment.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager, recommends acceptance of this grant.
